State of Florida Voluntarily Dismisses All Claims Against Defendants Axiom Worldwide

On July 13th, 2012, Mr. James Gibson, President & CEO of Axiom Worldwide, Inc. announced that the State of Florida, Department of Legal Affairs, Office of the Attorney General voluntarily dismissed their claims against Axiom Worldwide, Inc. and Axiom Worldwide, LLC effectively ending the litigation between the Axiom entities and the state. The case was styled *State of Florida, Department of Legal Affairs, Office of the Attorney General vs. Axiom Worldwide, Inc. et al*, and was filed in 2009 in the Circuit Court of the Thirteenth Judicial Circuit of Hillsborough County, Florida. The lawsuit was largely based on alleged improper marketing and representations by the collective Axiom defendants. Axiom has always publicly denied these allegations. Of a more important note, Axiom has never had to file a defense with the courts in this matter. It was the state that unilaterally determined to discontinue the litigation previously filed against the Axiom Worldwide entities when it filed its notice of voluntarily dismissing its claims--with prejudice.




